EXECUTIVE DIRECTOR STATEMENT

This has been an extraordinary year for our organization. We are honoured to continue supporting Ontario's diverse dance sector, its artists, and its practitioners through our services and offerings.

DUO's Annual Report offers a snapshot of the past year and some of our goals and aspirations for the year ahead. It is published after our Annual General Meeting, the closing of our Financial Statements for 2021-2022, and the election of the 2022-23 slate of board directors.

This past year, DUO undertook new initiatives, strategic planning and attendance at industry markets and conferences. I am reflecting with the staff and board as we plan, asking ourselves, "What can we do to better serve Ontario dance artists and companies?"



This fall, DUO released its Research Study and Needs Assessment on Dance Rehearsal Spaces in Ontario. Working collaboratively with Nordicity and Bridget MacIntosh and Associates, this year-long research study provided important paths for Ontario's dance sector to address rehearsal space concerns in the long term. This study employed a robust methodology that included community consultations, one on one interviews, a dance sector survey, rehearsal space inventory, and desk research and analysis.

The report identified seven action items to address the infrastructure issues the sector faces. Dissemination of the report included wide release across multiple platforms; an online presentation, which was recorded and made available on our website; the creation of 8 Tik-Tok style videos specifically for dance artists, highlighting the 7 recommendations was released on our social media channels and shared with other dance ASO's.

EXECUTIVE DIRECTOR STATEMENT

DUO was also invited to present its findings at a meeting on creative space by the City of Toronto. Other organizations attended and presented, including Arts Build Ontario, Why Not Theatre, Canada Council for the Arts, Ontario Arts Council, Toronto Arts Council, members of the City of Toronto team, the Metcalf Foundation, Kendra Fry Community Faith Spaces and Creative Collisions. DUO's board, staff, and stakeholders are planning our next steps to implement the reports recommendations starting in the year ahead.

DUO supported clients and met with presenters in Ontario, Canada and internationally at conferences and markets including tanzmesse (Dusseldorf), Ontario Presents Spring Retreat (Huntsville), CINARS (Montreal), Contact ON (Orillia), Festival TransAmerique (Montreal), and Montreal International Circus Conference (MICC). DUO staff attended the opening of the new venue Art Bank House in Welland, the first specially built space for circus in Ontario. Dance artists returned to stages in Ontario, nationally and internationally in force and with great enthusiasm. DUO was grateful to support so many artists in presenting new works this year. DUO met with clients Propellor Dance and the Ottawa Dance Directive in Ottawa and held open sessions for dance artists and companies in the region.

In November, DUO completed its new 3-year Strategic Plan led by Castledale Inc. and an Equity Diversity and Inclusion review with Cultural Pluralism in the Arts Movement Ontario (CPAMO). DUO's board, staff and clients provided input and insights that had our organization reflect and plan.

EXECUTIVE DIRECTOR STATEMENT

DUO held two workshops on building skills in the business of dance: Tour Readiness and Financial Literacy. The Tour Readiness workshop facilitated by Cameron Smilie was an opportunity for some of Ontario's programmers/presenters committed to presenting dance to meet with dance artists and companies for a half-day info-sharing session followed by a networking dinner. A Financial Literacy workshop led by Heather Young of Young Associates provided participants the opportunity to learn the language of accounting and become more confident with financial aspects of their businesses. Post workshop surveys to participants showed that not only were the topics appreciated but that DUO has a continued role to fill in building capacity and knowledge within Ontario dance.

I feel excited about the year ahead and confident that the work over the past year with our dedicated staff, board and community has positioned DUO to successfully continue to fulfill our mission to support building capacity across Ontario's diverse dance sector.

INDEPENDENT AUDITOR'S REPORT

To the Members of Dance Umbrella of Ontario

Opinion

We have audited the financial statements of Dance Umbrella of Ontario (the "Organization"), which comprise the statement of financial position as at June 30, 2022, and the statements of changes in net assets, operations and cash flows for the year then ended, and notes to the financial statements, including a summary of significant accounting policies.

In our opinion, the accompanying financial statements present fairly, in all material respects, the financial position of the Organization as at June 30, 2022, and the results of its operations and its cash flows for the year then ended in accordance with Canadian accounting standards for not-for-profit organizations.

Basis for Opinion

We conducted our audit in accordance with Canadian generally accepted auditing standards. Our responsibilities under those standards are further described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report. We are independent of the Organization in accordance with the ethical requirements that are relevant to our audit of the financial statements in Canada, and we have fulfilled our other ethical responsibilities in accordance with these requirements. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our opinion.

Responsibilities of Management and Those Charged with Governance for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with Canadian accounting standards for not-for-profit organizations, and for such internal control as management determines is necessary to enable the preparation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is responsible for assessing the Organization's ability to continue as a going concern, disclosing, as applicable, matters related to going concern and using the going concern basis of accounting unless management either intends to liquidate the Organization or to cease operations, or has no realistic alternative but to do so.

Those charged with governance are responsible for overseeing the Organization's financial reporting process.

Auditor's Responsibilities for the Audit of the Financial Statements

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance, but is not a guarantee that an audit conducted in accordance with Canadian generally accepted auditing standards will always detect a material misstatement when it exists.

Independent Auditor's Report to the Members of Dance Umbrella of Ontario (continued)

Misstatements can arise from fraud or error and are considered material if, individually or in the aggregate, they could reasonably be expected to influence the economic decisions of users taken on the basis of this financial information.

As part of an audit in accordance with Canadian generally accepted auditing standards, we exercise professional judgment and maintain professional skepticism throughout the audit. We also:

- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or
 error, design and perform audit procedures responsive to those risks, and obtain audit evidence that is
 sufficient and appropriate to provide a basis for our opinion. The risk of not detecting a material misstatement
 resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery,
 intentional omissions, misrepresentations, or the override of internal control.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Organization's internal control.
- Evaluate the appropriateness of accounting policies used and the reasonableness of accounting estimates and related disclosures made by management.
- Conclude on the appropriateness of management's use of the going concern basis of accounting and, based on the audit evidence obtained, whether a material uncertainty exists related to events or conditions that may cast significant doubt on the Organization's ability to continue as a going concern. If we conclude that a material uncertainty exists, we are required to draw attention in our auditor's report to the related disclosures in the financial statements or, if such disclosures are inadequate, to modify our opinion. Our conclusions are based on the audit evidence obtained up to the date of our auditor's report. However, future events or conditions may cause the Organization to cease to continue as a going concern.
- Evaluate the overall presentation, structure and content of the financial statements, including the disclosures, and whether the financial statements represent the underlying transactions and events in a manner that achieves fair presentation.

We communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit and significant audit findings, including any significant deficiencies in internal control that we identify during our audit.

RESEARCH STUDY AND NEEDS ASSESSMENT ON DANCE REHEARSAL SPACES IN ONTARIO

With support from **The Government of Canada**, **Ontario Arts Council**, **The Metcalfe Foundation** and **The City of Toronto**, DUO has engaged consulting firm **Nordicity** and Cultural Strategist **Bridget MacIntosh** to conduct a feasibility study and needs assessment around the Ontario dance community's rehearsal and creation space needs. The COVID-19 pandemic has forced the closure of many of these spaces – some, permanently. As we navigate this period of pandemic transition, and eventual recovery, Ontario needs sound data to support the rebuilding of the dance ecosystem. This study is the first of its kind for dance in Ontario.

The study/report includes a geographic overview of locations and facilities where professional dance artists create and rehearse, facility requirements (e.g., square footage) and where spaces would be best located to service multiple dance communities. BIPOC and new generation dance artists, and emerging leaders in Ontario's professional dance sector are a focus of this study. Ontario is home to several cultural hubs for professional dance, in urban centres and beyond. This report demonstrates the need for rehearsal spaces in various locations to serve diverse community needs, and present recommendations around post-COVID recovery.
